#### **Tree and Limb Drop Off:**

**Tuesday through Saturday 9am to 4:30pm except Holidays**

**Boyle County Residents Only (Proof of Residency Required)**

Trees and limbs **must be Free** of any foreign material such as: Staples, Nails, Wire, and Posts

Christmas Trees **must be FREE** of any foreign material such as: Lights, Ornaments, and Hangers

Industrial Wood Waste **must be** collected from Industrial locations by Cox Interiors

#### **NO: (STRICTLY ENFORCED)**

- Out of County Residents
- Trash, Wood mulch, Leaves, Grass clippings, Vines, and Bushes
- Stumps and Root balls
- Construction or Demolition, and Fence Posts
- Trunks or Limbs no wider than 24 inches and/or longer than 8 feet
- Industrial Wood Waste not transported by Cox Interiors



### **Fire Wood**

We ask that all good size tree trunks and limbs be placed separately for those residents wishing to use it as a heating source. This helps keep down our grinding cost while providing our residents with a FREE source of fire wood for winter heating. The fire wood is for any and all Boyle County Residents from April through November. From December through March all fire wood is given to Community Action to assist their clients in Boyle County. For your safety and our liability insurance **NO** chain sawing is allowed at the Alum Springs Convenience Center.



### **Industrial Lumber**

Boyle County Fiscal Court has provided a site at the Alum Springs Convenience Center for Industrial wood waste disposal. A growing part of the Industrial community is partnering with Boyle County Fiscal Court and Cox Interiors to reduce their solid waste cost and recycle industrial wood waste into energy. The Industrial wood waste collection is scheduled, picked up and transported (\$) by Cox Interiors to Alum Springs Convenience Center. ### **Wood Chips**

Boyle Counties' wood chips are made up of residential (trees and Limbs) and industrial wood waste. The Boyle County Fiscal Court and the City of Danville share the cost of grinding trees and limbs. Boyle County Fiscal Court has a contract with Cox Interiors, out of Campbellsville KY, to grind and transport chips to their plant. At the plant a mixture, Federal and State guidelines, of residential (trees and limbs) and industrial wood waste is created and placed in a boiler (Biomass) and used to generate electricity to run the facility. Due to this process Boyle County Fiscal Court and the City of Danville receive a discounted rate on grinding and transporting.
