In accordance with KRS 198B.060(10) and Boyle County Ordinance 340.3, sections 9, 12, and 20:

Applicant/Agent is responsible for notifying this office when the project is ready for the various stages of inspection. Failure to follow the above agreement can result in: a stop work order, revocation of permit, a charge of a Class B Misdemeanor, which is punishable by a fine of up to \$250.00 and/or up to 90 days in jail. Any violation of the licensing provision of the ordinance is punishable by a fine from \$10.00 up to \$500.00.

All contractors and sub-contractors shall provide proof of contractor's license, proof of general liability insurance of at least \$350,000, proof of Worker's Compensation Insurance for all persons working on the project and proof of compliance with the Danville and/or Boyle County Occupational License/Net Profits Ordinance.

ALL CONTRACTORS ON THIS PROJECT ARE EXPECTED TO HAVE KNOWLEDGE OF THE APPLICABLE BUILDING CODES CURRENTLY IN EFFECT.

- FRAMING** - WHEN PROJECT IS TOTALLY FRAMED UP, AFTER SERVICE ROUGH-IN INSPECTIONS, BEFORE INSULATION AND DRYWALL
- FINAL** - WHEN ALL FINAL SERVICE INSPECTIONS ARE COMPLETED; HOUSE IS READY TO OCCUPY

BEFORE BUILDING PERMIT IS ISSUED:

IT IS THE RESPONSIBILITY OF THE APPLICANT TO ENSURE ALL CONTRACTORS HAVE A CURRENT BOYLE COUNTY CONTRACTOR'S LICENSE.

THIS LIST MUST BE SUBMITTED TO BUILDING INSPECTOR'S OFFICE BY THE PERMIT APPLICANT. IT MUST CONTAIN THE CONTRACTORS LICENSE NUMBER . (EXAMPLE: CL0001)

THE APPLICANT CAN REQUEST ISSUANCE OF A PERMIT IF 75% OF CONTRACTORS LICENSE NUMBERS ARE LISTED. THE REMAINING CONTRACTORS MUST BE SUBMITTED BY FRAMING INSPECTION.

FAILURE TO TURN IN COMPLETE LIST CAN RESULT IN THE HOLDING OF A CERTIFICATE OF OCCUPANCY OR A STOP WORK ORDER FROM THE BUILDING INSPECTOR'S OFFICE.
